Care Instructions:

Please note that dirty clothing may lead to a reduction in protection. It is recommended that a wash temperature of 40c be used. The wash programme used should be that for delicates with normal spin and rinses. Do NOT tumble dry, flat dry only.











Storage: Always store in clean, dry conditions, away from direct sunlight. this garment is suitable for transportation as supplied by the manufacturer.

Repairs: All repairs are to be carried out to the relevant regulations.

This garment has been designed to give a specified level of protection against accidental contact with flame and against certain forms of heat transfer.

The garment conforms to EN ISO 11612:2015: Protective clothing for industrial workers exposed to heat (excluding Fire Fighter and welders clothing). It meets the following requirements.

Code letter A - Limited flame spread (Face A1)

Code letter B - Convective heat (to level B1)

Code letter C - Radiant heat (to level C1)

It is not designed to protect against molten aluminium and iron splash (code letters D and E) or for use in welding and similar activities.

Wearer Notes:

The wearer should not remove this garment whilst in the presence of flammable or explosive atmosphere or while handling flammable or explosive substance.

This garment should not be used in oxygen enriched atmospheres without prior approval of the responsible safety engineer.
